

## Terms and Conditions

**Campaign Dates:** Till June 25 , 2018 (hereinafter referred to as “Offer Period”)

### **Details of the Offer:**

Citibank and Goibibo (“GI”) are launching offers (hereinafter referred to as “Offers”) for the above mentioned Offer Period. Details of the offer extended to all individuals holding valid Citibank Credit & Debits cards (hereinafter referred as “Card”) issued in India, except Citi Corporate Credit cards (hereinafter referred to “Customers”) are detailed herein below.

The below are the details of the offers.

### **Domestic Flights:**

- Offer is valid for domestic flight booking done between 14:00 hrs to 21:59 hrs on every Mondays during the Offer Period
- Domestic flight offer will be valid **only on Goibibo Android & iOS Mobile App**
- Offer is valid for a cashback of INR 1200
- Offer is valid on a minimum ticket value of INR 5000 excluding any ancillary purchased (meals, insurance etc.)
- The customer must enter the promo code ‘GOCITI’ in the Deal Code field on the Goibibo app.
- Customers using Citi Credit and Debit card only get INR 1200 cashback to card on Domestic Flight bookings made during the offer period.
- The domestic flight offer is valid only on the first eligible transaction per card per Monday during the Offer Period.

### **Detailed Terms and Conditions**

- The Offer is only valid on bookings made using Citibank Credit and Debit cards issued in India.
- This Offer is NOT applicable on Citibank corporate credit cards.
- Add-on cards will be treated as separate cards.
- In the event of Citi Card being used to make a subsequent booking, it will be eligible for regular offer but not for the offer on Citi Cards.
- Transactions completed during this Offer Period with the appropriate deal code will only be considered. The date of travel can be beyond the expiry date of the offer.
- **The cash back on Citi cards across offers on Flights and Hotels will be provided in the Customer’s card account within 60 days from the date of transaction.** The time line provided for effecting credit is only indicative of expected period and may vary from the actual date of credit.
- For all bookings, the cashback amount shall be credited to the same credit/debit card as was used for the purpose of making the booking, and will reflect in the monthly card statement/s.
- This Offer is also valid on EMI transactions on Credit Cards
- Citibank merchant EMI Terms & Conditions will be applicable on EMI transactions as mentioned at: <https://www.online.citibank.co.in/card-offers/pdfs/EMI-TC.pdf>.
- Cashback will be calculated on each Booking ID and not on the number of transactions.

- If the Customer does not receive the cashback amount, he/she can claim for the same within 4 months from the booking date. In the event the Customer fails to do so, he/she will not be eligible for the cashback amount.
- Products and services are subject to availability.
- Offer is not valid on payments made through PayPal account, Cash on Delivery (COD).
- Offer cannot be clubbed with goCash and goCash+.
- For any card related claims/ issues, the customer shall approach Citibank and Goibibo shall not entertain any such claims.
- The Customer cannot club any other offers along with this offer on the same booking ID. The Offer cannot be transferred/ assigned to any other person or Customer.
- The Customer shall not be entitled to cashback in the event of cancellation of booking. If the Customer cancels the travel service purchase after the cashback amount is credited, Goibibo will refund the purchase price after deducting the cashback amount and any other applicable cancellation charges/penalty. For example, if a Customer has paid INR. 10,000/- (price quoted by Goibibo) for a travel service and a cashback of INR 1,000 has been credited to the Customer's account, the net amount paid by the Customer is INR. 9,000. Thus, if the Customer cancels the booking, Goibibo will deduct the cancellation charge/penalty from INR. 9,000/- and the balance amount will be credited to the Customer's account.
- In the event of rescheduling, the Customer shall bear the fare difference (regardless of whether the component is in the base fare or in tax + surcharge) and other applicable rescheduling fees.
- User Agreement and Privacy Policy at Goibibo website shall apply.
- Customers, who are Travel Agents by occupation, are barred from making bookings for their customers and Goibibo reserves the right to deny the Offer against such bookings and to cancel such bookings. For such cases, Goibibo will not refund the booking amount.
- Goibibo will be entitled to reject any claim in case there is any abuse/misuse of the Offer by the Customer or the claim is not eligible under the offer.
- Citibank and Goibibo reserves the right, at any time, without prior notice and without assigning any reason whatsoever, to add/alter/modify/change or vary all of these terms and conditions or to replace, wholly or in part, this offer by another offer, whether similar to this Offer or not, or to extend or withdraw it altogether.
- In no event, the entire liability of Goibibo to a Customer, entitled under the said Offer, for any dispute arising in connection with this Offer, shall exceed the cashback amount.
- The T&Cs of this Offer shall be governed by the laws of India. Disputes, if any, shall be subject to the exclusive jurisdiction of the competent courts/tribunals in New Delhi only.
- Any disputes regarding delivery, service, suitability, merchantability, availability or quality of the Offer and/or products/services under the Offer must be addressed in writing, by the Customers directly to Goibibo and that Citibank shall not entertain any communication in this regard.
