

Terms and Conditions

Citibank, N.A. ("Citibank/Citi") is launching the Offer (hereinafter referred to as "**Offer**") for the below mentioned Offer Period. Details of the Offer extended to all resident individual savings account holders holding valid Citigold World Debit Card, Citigold Private Client World Debit Card, Citigold VISA Infinite Debit Card and Citigold Private Client VISA Infinite Debit Card (hereinafter referred as "**Card**") issued in India, are detailed herein below.

Offer period: 00.00 hours on 1st Oct 2022 to 23:59 hours on 31st Dec 2022

Offer Details

Citigold Private Client and Citigold clients with a valid Debit Card as mentioned above issued in India will be eligible for :
